

## **Integrated Managed Care Service Encounter Reporting Instructions (SERI) – Interim Guidance 12-18-2020**

The following guidance applies to the Service Encounter Reporting Instructions (SERI) issued for July 1, 2019 (<a href="https://www.hca.wa.gov/assets/billers-and-providers/SERI v2019-1EffectiveJuly1">https://www.hca.wa.gov/assets/billers-and-providers/SERI v2019-1EffectiveJuly1</a> 2019.pdf).

HCA requests that Managed Care Organizations and Behavioral Health – Administrative Service Organizations adopt the following changes in CPT® codes effective 1/1/2021. These changes will be formally added to the next release of the SERI guide, anticipated to be released early 2021. Any additional changes in the next SERI release will be expected to be implemented 90 days from the release date.

Deleted code - Effective 1/1/2021, the following CPT® code is retired and replaced in the Intake Evaluation modality section for Mental Health Services on page 42 of the current SERI:
