The purpose of this email is to inform HCAs contracted partners of a change in BHDS that must be implemented on or before April 5, 2024.

The change is to add the Provider NPI field to the body of the following supplemental data transactions:

- Client Demographic 020.08
- Client Address 022.03
- Funding 140.02

The above transaction codes (20.08, 22.03, 140.02) will continue to be accepted in BHDS as they are structured in BHDG 5.7.

On April 5, 2024, HCA will not accept the old transaction codes (20.08, 22.03, 140.02) if the effective date \Rightarrow 4/5/2024.

The new transaction codes for each of the three transactions are listed below and are attached to this email. The attachment includes the table structure with the "Provider NPI" field added to the bottom of the body of each transaction.

The "Provider NPI" field will be a required field and must be the same Billing Provider NPI submitted in Loop 2010AA, NM1*85 segment on encounter data.
