

**AMENDMENT NUMBER FIVE  
ADMINISTRATIVE SERVICES AGREEMENT**

This Amendment Number Five (“Amendment”) is entered into as of by and between Coordinated Care of Washington, Inc. (“CCW”) and Greater Columbia Behavioral Health, LLC – Administrative Services Organization (“GCBH-ASO”). Hereafter, CCW and GCBH-ASO may be referred to individually as a “party” and collectively as the “parties”.

WHEREAS, CCW and GCBH-ASO have previously entered into an Administrative Services Agreement (the “Agreement”) effective as of January 1, 2019 (defined in the Agreement as the “Effective Date”); and

WHEREAS, the Parties desire to amend the Agreement;

NOW THEREFORE, in consideration of the promises and mutual covenants herein contained, the Parties agree as follows:

1. The existing ATTACHMENT C COMPENSATION DUE BH-ASO FOR ADMINISTRATIVE SERVICES shall be deleted from the Agreement in its entirety and replaced with the attached ATTACHMENT C COMPENSATION DUE GCBH-ASO FOR ADMINISTRATIVE SERVICES
2. All other terms and conditions of the Agreement and any amendments thereto, if any, shall remain in full force and effect. If the terms of this Amendment conflict with any of the terms of the Agreement, the terms of this Amendment shall prevail.

**EXHIBIT C**  
**NETWORK: CCCWA**  
**COMPENSATION DUE GCBH-ASO FOR ADMINISTRATIVE SERVICES**

Health Plan shall compensate GCBH-ASO as follows for GCBH-ASO's provision of the Administrative Services under this Agreement for the Integrated Managed Care (IMC) and Integrated Foster Care (IFC) members:

1. CCW shall pay to GCBH-ASO for IMC/AHE members in consideration for the Behavioral Health Services for which GCBH-ASO arranges:
  - a. Effective January 1, 2025, \$3.39 PMPM for IMC/AHE members as set forth in Exhibit B ("Administrative Services").
  - b. GCBH-ASO shall be entitled to ten percent (10%) of the expenditures for the crisis services listed in Attachment B, for administrative costs. This 10% of administrative cost is included in the above stated PMPMs.
  
2. CCW shall pay to GCBH-ASO for IFC members in consideration for the Behavioral Health Services for which GCBH-ASO arranges:
  - a. Effective January 1, 2025, \$7.08 PMPM for IFC members as set forth in Exhibit B ("Administrative Services").
  - b. GCBH-ASO shall be entitled to ten percent (10%) of the expenditures for the crisis services listed in Attachment B, for administrative costs. This 10% of administrative cost is included in the above stated PMPMs.
  
3. Plan shall pay the Monthly Payment to GCBH-ASO by electronic funds transfer on a monthly basis no later than the 7th day of the month, or business day following the 7th day of the month if the 7th day is a weekend or a federal holiday. Retroactive reconciliation based on member months shall be done as specified in this Agreement.
  
4. GCBH-ASO and CCW shall participate in financial reconciliation process, as directed by HCA, related to predicted versus actual Crisis Services utilization and fees and expense for direct services provided to CCW Members. Administrative fees will not be reconciled, unless otherwise directed by HCA. Reconciliation may result in the identification of an overpayment or underpayment by CCW to GCBH-ASO for the Covered Crisis Services provided under this Agreement. In the event there is a positive balance after reconciliation, such that CCW overpaid for Crisis Services, CCW reserves the right to reclaim that balance after the semi-annual reconciliation is completed. In the event there is a negative balance after reconciliation, GCBH-ASO reserves the right to request reimbursement of additional funds if the reconciliation shows the currently negotiated PMPM did not cover the costs of Member utilization of Crisis.

5. Per the GCBH-ASO Agreement, GCBH-ASO shall submit claims and/or encounters for Covered Crisis Services consistent with the provisions of the GCBH-ASO Agreement including, but not limited to Claims Encounters Delegation Grid.
6. These rates include the January 1, 2024 15% legislated increase.
